## *Agreement for Enrollment*

---

### *Grooming Course Hours*

Bow Meow Pet Grooming School is a 420 hour course. Classes are held for three hours each day on Mondays, Tuesdays and Thursdays. Saturday will be a four-hour lab class. Classes begin at 5:30 p.m. and end at approximately 8:30 p.m. Students are expected to be on time and attend each class.

### *Requirements for Certification*

Throughout the course, students will receive weekly progress reports. Upon successful completion of the program, students will receive a certificate stating successful achievement of all classes.

### *Tuition*

Bow Meow Grooming School tuition is \$5,200. A \$100 one-time non-refundable application fee must accompany this application. Tuition will include all materials and supplies that will be used at the school. A grooming kit will be optional and available for all students.

Students may apply for loans for tuition through their own bank. Payments can be made by cash, check, Visa or Mastercard or through other financial arrangements.

Once the student has been accepted, \$1,000 per month will be due on or before the 6th of each month. The acceptance by the student and the teacher is a serious commitment and therefore, payment must be paid when due otherwise, classes may be terminated for that student. Special circumstances may be dealt with privately between the teacher and the student.

Tuition does not include any overnight accommodations, transportation or other expenses connected to this enrollment.

### *Refund*

No refunds will be made except for the following:

Any student who does not meet the requirements for admission or has decided before classes begin that they wish to decline may receive a full refund.

### *Termination Policies*

Students must provide Bow Meow Pet Grooming School with written notice if they wish to resign. Any student with excessive days of absences shall be deemed to have cancelled his or her enrollment.

A student with insufficient academic progress, nonpayment of tuition or failure to comply with the requirements of the school may be asked to leave without completion of the classes.

Students are expected to be professional at all times and should dress appropriately for this profession, ie: sensible shoes and clothing.

Any misconduct may be grounds for the termination of the classes for that particular student. Misconduct could be one or any of the following:

- All types of dishonesty.

- Theft or damage to the school or premises.

- Failure to comply with directions of owners/employees.

- Disorderly conduct or lack of control that puts any person or animal in jeopardy at the school.

- Disregard of policies of the school.

- Failure to make tuition payments.

- Alcohol is not allowed on the premises.

- Consuming on the property could be grounds for termination.

### *Concern and Risks*

No experience is necessary for any of these classes. Students must be 18 years of age. Students should have affection and have a serious concern for all animals that they will work with.

To succeed in this program and this profession, students should understand that they will need to stay mentally focused, stand most of the day, have good dexterity of the use of their hands and arms and be able to lift at least 40 pounds without any problems.

All students must acknowledge the risks associated with working with

animals. The students hereby agrees not to hold Bow Meow Pet Grooming School, any of its employees or agents or its owner, Cindy Cross, liable for any injury caused by an animal in the school's custody while the students are enrolled in the grooming school. Possible injuries include, but are not limited to bites, scratches infections, parasites or other diseases.

All students will be required to get an up-to-date tetanus vaccination.

### *Withdrawal*

Students who wish to terminate their classes should write a letter stating so to the director of Bow Meow Pet Grooming School.

### *Employment*

Students who successfully complete all classes and lab work at the Bow Meow Pet Grooming School will be given references upon the completion of all work if requested. Bow Meow Pet Grooming School will attempt to help students find employment but there is no guarantee that students will obtain employment when the classes have been completed.
